Our Guiding Principals

- Equity forms the foundation of our work
- We will confront the most complicated and difficult issues surrounding anti-racism and equity, rather than only focusing on the easiest issues to address
- Identities are intersectional and complicated
- Voices and perspectives of those with lived experience (context experts: youth and caregivers) guide our recommendations and the committee's work

Context Expert Advisory Committee

- Approximately 15 diverse individuals (Caregivers and youth)
- Quarterly Meetings
- Compensated for their time and expertise
- Provide meaningful participation input into
 - Overall project
 - RFP process
 - Innovative Interventions

Equitable RFP Process

- Input from context experts (caregivers and youth), professionals and Network Stakeholders
- Broad dissemination of RFP on traditional and nontraditional platforms
- Blinded applications once submitted
- Simplified application process
 - No 501(c)3 required
 - No budget or program design
 - Open to large and small organizations

Independent RFP Review Committee

- Approximately 15 diverse individuals (Professionals, caregivers and youth)
- Commit Approximately 6 hours to reviewing and scoring applications
- Compensated for their time and expertise


Instructions for Breakout
