Strategies for Ensuring Access to Emergency Contraception: A Checklist for Family Planning Staff



This checklist was created to support family planning staff in ensuring that all people have what they need to achieve full reproductive autonomy, including access to emergency contraception (EC). Strategies for ensuring access to EC—to prevent pregnancy following unprotected or inadequately protected sexual intercourse—focus on improving knowledge and skills among staff and clients, in conjunction with maintaining sound fiscal and operational processes. Using this checklist, family planning staff will be able to see where they have already incorporated strategies to ensure EC access, as well as consider additional strategies for improving this access.

Within the categories of: 1) training for family planning staff; 2) billing and coding training and tools; 3) organizational strategies; and 4) provision of EC, this checklist lists multiple strategies to consider for ensuring access to EC.

Here's how to use this checklist:

- 1. Assemble a team of two or more staff members of diverse roles and responsibilities.
- 2. Check each strategy that is already being implemented at your agency.
- 3. Reflect on your responses under each of the checklist's four categories.
- 4. Review the strategies that remain unchecked to identify potential areas of improvement.
- 5. Determine which strategy (or strategies) to prioritize for ensuring access to EC.
- 6. Revisit this checklist annually and aim to incorporate a new strategy each time.

Training for Family Planning Staff

Train all staff on EC basics: What is EC? What are the different types of EC? How does EC prevent pregnancy? What are the disadvantages/side effects to EC? How effective is EC in preventing pregnancy?

	Ensure client education materials and reminders on EC are embedded in electronic health records (EHR) to prompt family planning providers and staff to address EC at every visit. Consider creating EHR quick charting templates to decrease the burden of documenting EC provision.

Develop and establish clinic policy that includes advanced supply of EC and devices as a routine clinical practice

Institute a same-visit strategy that includes same-day provider-dependent methods (IUDs, IUS, implant) without a clinic appointment

Allow for telehealth appointments with direct medication mail services for provision of EC without an in-person clinic visit

Prepare I&E Committee approved EC information to be distributed upon clients' requests

Provide referrals and warm transfers for clients who desire EC, but are unable to receive their method of choice at time of visit

Providing Effective Referrals Training Guide (RHTNC)

Include information on how to access EC within the Title X network and outside traditional clinic settings (telehealth, online contraceptive platforms, and over the counter) in Community Participation, Education, and Project Promotion (CPEP) activities

- EC can be provided to non-Title X clients and/or without the use of the Title X sliding scale at community events, through the mail, or through partnerships with other community organizations.
- Using Virtual and Remote Outreach to Meet CPEP Requirements Job Aid (RHNTC)

Provide EC to non-Title X clients outside the clinic setting and/or without the use of the Title X sliding fee scale. Consider partnerships with schools or college campuses to improve access to EC.
